PRESIDENT POSTION:

The position of President is open for nominations.

Election will take place at the September 7th General Meeting.

The President is an elected official with a two (2) year term and must be a GPAA member. Since Chester was just re-elected his term will expire in April 2018.

Qualifications as per our Bylaws:

President

Shall be the chief executive officer of the Corporation and shall be primarily responsible for the operations of the Corporation. He/She shall be responsible to set goals and direction, and to implement programs to achieve them. As determined by the Board, the President/Chairperson shall appoint a Parliamentarian who shall be knowledgeable of Roberts Rules of Order. As Chairperson of the Board, the President shall preside at all meetings of the Members and of the Board of Directors. He/She shall sign all deeds and conveyances, all contracts and agreements, and all other instruments requiring execution on behalf of the Corporation, and shall act as operating and directing head of the Corporation, subject to policies and limitations established by the Board of Directors. In case of the permanent absence or inability of the President/Chairperson to act, that office shall be declared vacant by the Board of Directors and a successor shall be chosen by the Board, subject to the approval or disapproval of the general members at a regular or special meeting called for that purpose. *(taken from TSSD's Bylaws)*

The President also:

- Renew contract with Joslyn Senior Center for use of auditorium every November/December.
- Files form SI-100 Statement of Information with the California Secretary of State that shows that we are still a Corporation and a list of current officers each year.
- File Tax Statement with the San Diego County Board of Equalization (BOE) on the items sold during the year (dowsing rods, gold bags, etc.)
- File a list of elected Officers each year with the San Diego County Board of Equalization (BOE). This requires 'original' (or 'wet') signatures of the officers and their driver license.

- File the yearly application, form CT-NRP-1, to the State of California, Department of Justice DOJ for having raffles.
- File monthly form CT-NRP-2, monthly income and expenses of each raffle, to the Department of Justice (DOJ)
- File with the State of California, State FTB form 199-N.
- File with the Federal Government, form 990-N.
- Overseas all positions/duties pertaining to Treasure Seekers of San Diego.

And all the other, non-listed, aspects of the position of President of a Not for Profit 501(4) c.

What was the last year US silver coins were minted?

1964 was the last year that circulating U.S. coins were struck in 90% silver.

The composition of U.S. coins has changed considerably over the past few decades. Because of a growing worldwide silver shortage, the Coinage Act of 1965 authorized a change in the composition of dimes, quarters, and half-dollars, which had been 90 percent silver. Silver was eliminated from the dime and the quarter. The half-dollar's silver content was reduced to 40 percent and, after 1970, was eliminated altogether. This applies ONLY to coins minted for everyday use with the general public. The US Mint is still minting yearly sets of SILVER PROOF Coins that you can purchase from them if you'd like. Other denominations dollar coins dated 1971 and later are either cupronickel or brass.

Nickels have always been made from copper and nickel, except during WW2 when they contained a small amount of silver. There has never been a 90% silver nickel.

Hawaiian SPAM-tastic Pizza

1- 10 oz. already made pizza crust
1/2 cup pizza sauce, from a jar
6 ozs. Provolone cheese, grated
1 can (12 oz.) SPAM, any flavor thinly sliced or cubed
1 can (16 oz.) Pineapple Chunks, drained
1/2 cup thinly sliced red onion
1/2 cup peppers red, green, yellow or a combination (optional)

Heat oven 425 degrees

Grease a 14" pizza pan or a 13"x9" pan

Unroll dough and press in pan

Top dough with the pizza sauce, cheese and arrange the remaining ingredients

Bake 25 -30 minutes or until the crust is deep golden brown

August 20th One Day Outing:

TSSD's August outing will be on Saturday, August 20th, 2016 at the Blue Cut/Cleghorn (Cajon Pass) area.

9 AM meet

At the Monument in the dirt parking lot with shade trees.

Spend the day sluicing, panning, metal detecting, exploring in and around Cajon Wash Creek.

Bring your own equipment (or share with someone), shovels, picks, gold pans, sluice box, scoops, buckets, chair, food, water and whatever else.

A change of foot wear is recommended as you will be in the water.

Lots of history in this area:

Cajon Pass, separating the San Bernardino and San Gabriel ranges has long been an important natural gateway. It is traversed by Indian trails, emigrant routes, railroads, and a superhighway. Early in the 19th century it became the southern end of the Old Spanish or Salt Lake (Mormon) trail. In the 1840s it was the scene of massive horse-stealing raids led by Indians and renegade mountain men, in which as many as 5000 head at one time were driven eastward. The Mormon pioneers who founded San Bernardino in 1851 traveled this route. In 1861 John Brown built a 12-mile toll road through the pass. It connected with the Van Dusen Road, providing improved access to the booming mining settlements in Holcomb Valley. The lower end of Cajon pass consists of a huge alluvial deposit 2 miles wide. About 5 miles above Devore is a narrow gorge eroded by Cajon Creek known as Blue Cut, also called lower Narrows. A Tollhouse for the Brown road was located nearby. This became the logical path for the railroad, which came in 1885. It was also the route of old Highway 66. The construction of Interstate 15 has largely removed this once familiar landmark from the public eye.

Directions from Escondido:

Hwy. 15 North to Exit 124 Kenwood Ave. Make a left turn, and go under the overpass to stop sign. Right turn at stop sign, (Cajon Blvd.) and go about 4 miles. There will be a parking area on the left under trees by the Blue Cut Monument.

If the Exit 124 is closed for road construction, go up the grade to Exit 129 Cleghorn Road. Make a left turn, go under the overpass and make a left turn on Cajon Blvd., go about 5 miles or so, and just after passing Swarthout Canyon Rd., the Blue Cut will be on the right side of the road.

Not sure if you need an Adventure Pass, but it would not hurt to have one.

There are no restrooms in this area.

TSSD Membership:

Membership to Treasure Seekers of San Diego is free. We do not charge an annual due. All that is asked is that you attend meetings, participate and support the group through its opportunity drawings and events. To maintain membership, you **MUST** attend one meeting every quarter.

1st meeting: Complete and turn in a membership application.

2nd meeting: You will be given your TSSD membership card.

3rd meeting: You will be able to purchase a TSSD Claims Guide with proof of your membership card.

G.P.A.A.:

Treasure Seekers of San Diego is a chapter of G.P.A.A. This does not require you to become a member of G.P.A.A. but if you are, please advise them that you are also a member of TSSD, so that we are eligible for 'points' from your membership. TSSD uses those 'points' to obtain opportunity raffle items.

Conduct and Code of Ethics

Members shall conduct themselves in the highest ethical standards and reflect no discredit upon this association. This standard shall be one of the qualifications for membership in this association. Any violation of these standards shall be deemed grounds for expulsion.

How many is too many?

How many 'guests 'on our claims is too many?

Re-read your Claim Rules and Regulations that you signed when signing your membership application (a copy is in the claims guide – 3rd page, 3rd paragraph).

“The TSSD claims are for the use of TSSD members only. A guest can only go to the organization claims with a TSSD member. A limit of 2 guests with an additional 2 guests by permission of the TSSD President. The guest is limited to two visits and then must then become a member of the TSSD and purchase a TSSD Claims Guide. Unruly guests are the responsibility of the corresponding TSSD member.”

So those of you who invite more than 2 guests, time after time after time, are in violation of TSSD Claim Rules and Regulations and will place you in a NOT good standing with the association and your membership can (and will) be withdrawn.

Police yourself.

Don't ruin it for yourself or others.

TSSD has equipment that it loans to its members. All we ask is that anything that is checked out is returned in the same or better condition than when it was borrowed. It is understandable that with the nature of our hobby, the equipment will get some bumps and bruises, which is acceptable. But if parts are lost or broken, it is the responsibility of the ‘borrower’ to repair or replace missing or broken parts. Further details of the equipment check out policy is on the form which you will sign when receiving the item.

Earl Sterrett, 858-922-4547, will be able to assist you with the equipment checkout. He asks that you give him a couple of days’ notice when you might need something, and when items are returned that they are CLEAN. **All equipment must be returned by the meeting following from when it was checked out.** Equipment is located at Valley Rose Self Storage, 1566 E. Valley Parkway in Escondido.

Claims Assessment Work Form:

Each and every time you are at one of TSSD's claims, you should be completing a Claims Assessment Work Form (located in the front of the claims guides or at the meetings from the Claims Guide Seller). This form needs to be turned into Robert Cook, TSSD Claims Manager, at the meetings or e-mailing it to him at: rmjcc@cox.net or surface mail to: 1941 Rockhoff Road, Escondido, CA 92026-1113.

Needed information required: Claim used, Members name, Date used, Total people prospecting and time on the claim, Type of work done (clean up, maintain, filling in holes, etc.), Members signature, Claims access, Vehicle access, Claim Markers, Claims Guide Directions, Type of equipment used, Type of gold found.

It sounds like a lot, but it really is not. This information is needed to prove that our claims are being worked. If BLM questions us as to the use of our claims or wants to close one of our areas to prospecting, we want to be able to produce records that show that our claims are being used.
